

Information Note

Airport Bus and City Airport Train

There are several ways of getting from Vienna International Airport to the United Nation's offices or the centre of Vienna, including metered taxis readily available outside the airport and a direct train service to the Centre (City Airport Train – CAT). Upon leaving the baggage collection area, one can see signs for taxi, CAT and buses immediately ahead.

To access Vienna International Centre (VIC) from Vienna International Airport, a particularly convenient means of transport is the "Post Bus" which travels directly to VIC – UNO City where the meeting is to take place.



The bus stop is located immediately outside the building, Bus Number: 1183 Airport Vienna <-> UNO City (Wien Kaisermühlen VIC). A one-way ticket on this bus will cost €8. You can buy tickets directly on the bus. The journey lasts approx. 30minutes.

Departure at Airport: **every 60 minutes** at **minute 10'** (7.10 a.m. - 8.10 p.m.)

Departure VIC (Return): **every 60 minutes** at **minute 10'** (6.10 a.m. - 7.10 p.m.)

Access to the VIC

Participants coming by "Post Bus" or the "U-Bahn" on line 1 should get off at "Kaisermülen-Vienna International Centre", leave the station following the VIC sign, and enter VIC grounds at Gate 1.



Participants coming by taxi are advised to leave the vehicle in the side lane of the Wagramer Strasse and enter through Gate 1.

Registration and security arrangements

Security regulations at the VIC require that all participants pass the X-Ray check at the entrance and register in order to enter the VIC premises. Please bring your **passport** for this purpose.

To register for the conference, the details (name, title/function, workplace and individual e-mail address) of delegates should be sent to julia.widowitsch@unodc.org by Friday, 1 February 2013, at the latest. During pre-registration, Governments should ensure that the information on the composition of their delegations includes the individual e-mail address of each member of the delegation. Providing the individual e-mail addresses will ensure that all representatives receive an automatic e-mail response confirming their registration and any additional information that UNODC might need to send. The automatic e-mail response will also contain a link where each delegate may upload a photograph, thus shortening the time it will take to issue a grounds pass on the day of registration. Delegates who do not complete the pre-registration procedure will need to have photographs taken upon arrival at Gate 1 of the Vienna International Centre. All delegates are requested to confirm their attendance.

As part of the security arrangements, all participants are required to present their invitations or official communications identifying them as delegates, together with their passports or other official photograph-bearing identity documents, at the entrance before proceeding to the registration area and obtaining their grounds passes for the conference. Registration will take place in the Pass Office at **Gate I** on Thursday, 14 February 2013. Upon registration, participants will be issued VIC conference passes bearing their name and country or organization. For security reasons the display of conference/grounds passes is necessary for admittance to the VIC and must be worn at all times.

Meeting venue

The venue of the meeting will be Board Room B. It is located in the M building of the VIC.

Facilities at the Vienna International Centre

The Vienna International Centre has several facilities including a **post office**, **banks**, **medical services** and **travel service**, as well as cafeterias and restaurants.



The VIC Cafeteria is located on the ground floor of building F and offers a variety of hot and cold dishes, snack and drinks. Opening hours: 7.30 – 10 p.m. and 11:30 -3 p.m.

Coffee Bars are available on the ground floor of the M building is open daily 9 a.m. to 5 p.m. There is also a **Coffee Shop** at Gate 1.

Visas

Participants who require a visa for entry into Austria can secure their visas at the nearest Austrian diplomatic or consular office, or any diplomatic or consular authority of any State participating in the Schengen Agreement and acting on behalf of Austria.

Accommodation

UNODC regrets that it is not in a position to assist participants to make hotel reservations. Please be advised that the UN is located immediately at Kaisermühlen-Vienna International Centre on the red subway line U1.

We suggest that you arrange your accommodation in advance. Participants who arrive in Vienna without a hotel reservation can arrange hotel accommodation at Vienna International Airport at the travel desk located next to the information desk in the arrivals area. The travel desk is open from 8.30 a.m. to 9 p.m. daily.

Participation Costs

UNODC will cover the costs of travel and accommodation of speakers in accordance with UN rules and regulations but regrets that it is not in a position to cover costs for other participants.
