Excellencies,

As you well know, the member States of the Lisbon Union will meet in Geneva between 11 and 21 May 2015 for the adoption of a New Act of the Lisbon Agreement for the Protection of Appellations of Origin and their International Registration.

The review process started in September 2008 when the Assembly of the Lisbon Union established a Working Group on the Development of the Lisbon System. During six years of negotiations, the ten meetings of the Working Group have been systematically open to all members of World Intellectual Property Organization (WIPO). Rest assured that we will continue to work in the same spirit of dialogue and transparency throughout the Diplomatic Conference. We will remain open to discuss any proposals from observers, with the aim of improving the system, while "preserving the principles and objectives of the Lisbon Agreement", as set in the revision process decision.

With respect to the procedures of the Diplomatic Conference itself, and in response to the request of some countries to be granted the status of Member, we would like to emphasize that we are all bound by existing international law. In accordance with the principles recognised by the Vienna Convention on the Law of Treaties (particularly Articles 39 and 40), it is the States parties to an international treaty that negotiate and decide on the conditions of its amendment. We are also bound by the Lisbon Agreement (Article 13), which provides that the agreement "may be revised by conferences held between the delegates of the countries of the Special Union". We do hope that you will understand that the Observer status for the Nonmembers of the Lisbon system is in conformity with our international rights and obligations and is not, in any way, questioning our attachment to the values of inclusiveness and transparency in WIPO negotiation processes.

Excellencies, be assured that our approach is both positive and sincere, in perfect accordance with practices followed at WIPO since the organization was founded. We are committed to treating all the WIPO members, as well as the organization itself, with the greatest respect.

Please accept, Excellencies, the assurances of our highest consideration.
