## Your Excellencies:

We have the honour to draw attention to the fact that World Intellectual Property Organization (WIPO) Member States have enjoyed equal status in all WIPO Diplomatic Conferences for the last 25 years. This is no accident. Members have repeatedly chosen an inclusive and consensus-based approach that respects the interests and perspectives of all Members in the development of new international norms.

However, this well-established practice stands to be disrupted on 11 May 2015 when the 28 Members of the Lisbon Union convene a Diplomatic Conference to expand the scope of their existing treaty and create a new international system for the protection of geographical indications (Diplomatic Conference for the Adoption of a New Act of the Lisbon Agreement on Appellations of Origin and their International Registration). Regrettably, despite repeated requests for equal participation in this matter of interest to all, the broader WIPO membership has only been invited to attend as observers.

We strongly urge you, as a Lisbon Union Member, to reconsider this approach. We are concerned about the institutional implications for WIPO if its historically inclusive and consensus-based approach to international norm setting is overlooked by Lisbon Union Members. The broader WIPO membership has worked constructively with the Lisbon Union to date, and we wish to continue to make a good faith contribution. However, if the broader WIPO membership is to be genuinely and meaningfully involved – as it should be – the Lisbon Union must provide for equal participation in negotiations at the Diplomatic Conference. Your early support will encourage other Lisbon Members to enable a more inclusive process with a more widely accepted outcome.

Our interest in the negotiations is genuine. The protection of geographical indications is a subject matter of interest to all WIPO Members. Furthermore, stakeholders in all WIPO Member States stand to be commercially affected by decisions Lisbon Union Members will make, including intellectual property rights holders, agricultural producers and industrial producers.

The case for equal participation is compelling and should not be set aside lightly by a small group of Member States in a multilateral rule setting institution such as WIPO.
