

Informal Morning Afternoon Meeting – Thursday November 13, 2015.

Discussions on the Proposal of Mexico to move forward the discussion within the coordination mechanism.

The CDIP recommends to the GA to propose to WIPO Committees:

- (1). Upon completion of the substantive work of each session of the Committees, an opportunity should be provided for Member States who so wish to discuss those activities of the committee that have contributed to the implementation of the recommendations of the Development Agenda.

Upon completion of the substantive work of the last session before the GA of the Committees that have deemed themselves relevant for the purposes of the Development Agenda, an opportunity should be provided for Member States who so wish to make statements regarding those activities of the committee that have contributed to the implementation of the recommendations of the Development Agenda (Group B).

Upon completion of the substantive work of each session of all Committees, an opportunity should be provided for Member States to discuss those activities of the committee that have contributed to the implementation of the recommendations of the Development Agenda. (African Group)

Upon completion of the substantive work of each session of Committees, an opportunity should be provided for Member States to discuss those activities of the committee that they deem relevant and have contributed to the implementation of the recommendations of the Development Agenda. (African Group)

Upon completion of the substantive work of each session of Committees, an opportunity should be provided for Member States (to make interventions on) discuss those activities of the committee that they deem to ~~relevant and~~ have contributed to the implementation of the recommendations of the Development Agenda. (new chair proposal)

Upon completion of the substantive work of each session of Committees, an opportunity should be provided for Member States to make interventions on those activities of the committee that they deem to have contributed to the implementation of the recommendations of the Development Agenda. (modified chair proposal).

There will no standing agenda item for such statements, by member states, but such statements, if made, will be reflected in the meeting report (USA).

An Agenda item will be included in all committees entitled "contribution of the Committee to the implementation of Development Agenda recommendations incumbent upon it" (African Group).

- (2) The item to be included on the agenda must be entitled "Contribution of the Committee to the implementation of Development Agenda recommendations" incumbent upon it", following the language adopted in other committees and working groups.

The item to be included on the agenda must be entitled "Contribution of the Committee to the implementation of Development Agenda recommendations". (Provisionally Agreed – Proposal by UK).

This will be Standing agenda item under the title mentioned in point 2 (Brazil)

Under this agenda item, and upon completion of the substantive work of each session of the committees, an opportunity should be provided for Member States to discuss those activities of the Committee that they deem relevant and have contributed to implementation of the recommendations of the Development Agenda (African Group).

- (4) The report submitted by each Committee to the Assemblies shall include a summary by the Chairman of the Committee and the report will not be open to negotiations between Member States.

The report submitted by such Committees to the General Assembly shall consist of compilation of Member States statements and the report will not be open to negotiations among Member States. (Group B)

The report submitted by each Committee to the General Assembly shall include a summary by the Chairman of the Committee. (African Group)

The issue of Coordination Mechanism as such will mainly be debated within the CDIP, upon recommendation by the General Assembly (African Group).

- (5) The issue of the coordination mechanism as such will only be debated within the CDIP and discussions on its application in other WIPO committees will not be entertained, as these committees are not suited to that purpose.

The issue of the coordination mechanism, excluding relevance, will only be debated within the CDIP and discussions on its application in other WIPO committees will not be entertained. (Group B)

Committees shall bear in mind that the Coordination Mechanism is to be implement in a pragmatic way and ensure that discussions on this matters do not prevent such committees from accomplishing their substantive work, in line with the Development Agenda Recommendations (African Group).
