## Article 18 WPPT

used by performers or producers of phonograms in connection with the exercise of their rights under this Treaty and that restrict acts, in respect of their Contracting Parties shall provide adequate legal protection and effective legal remedies against the circumvention of effective technological measures that are performances or phonograms, which are not authorized by the performers or the producers of phonograms concerned or permitted by law.
